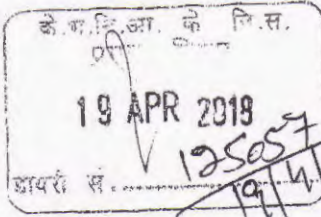

Subject:- Amendment in the guidelines of Pradhan Mantri Rojgar Protsahan Yojana (version dated 23.02.2017)-reg.

With the approval of Cabinet Committee on Economic Affairs (CCEA) the guidelines of PMRPY dated 23.02.2017 have now been revised to the extent that:

"Government of India will pay the full employer's contribution (EPF and EPS both) as admissible from time to time w.e.f. 01.04.2018 for a period of three years to the new employees and to the existing beneficiaries for their remaining period of three years through EPFO. The terminal date for registration of beneficiary through establishment is 31st March, 2019."
